## **SPECIFICATION FOR THE DISPLAY SCREENS / TELEVISIONS, MOVABLE SCREEN STANDS, ULTRA-WIDE MONITOR AND HDMI SPLITTER.**

The Information Regulator seeks to appoint a qualified service provider to supply six (6) 55-inch display screens/televisions and one (1) 34-inch ultra-wide monitor for use in the Security Operations Centre. Additionally, the service provider will supply three (3) movable screen stands, each capable of securely holding two 55-inch screens, and one HDMI splitter with six or more HDMI ports to connect the screens.

- **Display Screens/TVs (Quantity: 6)**

- **Type:** Commercial-grade LED/LCD/OLED (rated for 24/7 operation).
- **Size:** Minimum 55 inches
- **Resolution:** 4K Ultra HD (3840 x 2160 pixels) or higher.
- **Refresh Rate:** 120Hz or higher.
- **Brightness:** Minimum 400 nits.
- **Ports:** At least 4 HDMI 2.1 ports per screen.

- **Movable Screen Stands (Quantity: 3)**

- **Capacity:** Each stand must securely hold **2 screens** (55" or larger).
- **Mobility:** Heavy-duty wheels/casters with locking mechanisms.
- **Adjustability:** Height, tilt, and swivel adjustments for ergonomic viewing.
- **Cable Management:** Integrated channels/concealment for HDMI/power cables.

- **Ultra-wide monitor (Quantity: 1)**

- **Size:** 34 inches (ultra-wide)
- **Resolution:** 3440 x 1440 (QHD)
- **Refresh Rate:** 75Hz or higher (smooth visuals)
- **Response Time:** 5ms or less (reduce motion blur)

- **HDMI Splitter (Quantity: 1)**

- HDMI Splitter (1x6 configuration) to duplicate a single source across all 6 screens.

- **Warranty and Support**


- **Displays:** Minimum 3-year warranty (24/7 operation coverage).
- **Stands and Accessories:** 1-year warranty.
- **Technical Support:** Onsite installation and troubleshooting (preferred).

- The service provider to provide at least **2 references** where they have performed similar projects.
- The service provider will be required to deliver the equipment within **two (2) weeks** of an award letter or official purchase order

3. Most recent CSD registration report;
