SPECIFICATION FOR SUPPLY OF PASSWORD MANAGEMENT SOLUTION.

1. PURPOSE

1.1 The Regulator is soliciting quotations from qualified service provider for a cloud-hosted Enterprise Password Management (EPM) solution. The primary objective is to enhance our cybersecurity posture by providing a secure, centralized, and user-friendly platform for managing corporate credentials, eliminating the use of weak, reused, or stored-in-plaintext passwords.

2. PASSWORD MANAGEMENT SOLUTION REQUIREMENTS.

2.1 The solution must be a cloud-hosted platform within the borders of South Africa.

2.2 Number of Licenses: 150 users.

2.3 Duration of the Licenses: 12 months subscription.

2.4 Secure vault for storing passwords.

2.5 Cross-platform support (Windows, macOS, iOS, and Android).

2.6 Browser extension support for Chrome, Edge, and Safari.

2.7 Ability to generate strong, random passwords.

2.8 Functionality for managing shared (team) accounts and individual accounts.

2.9 Multi-Factor Authentication (MFA) integration.

2.10 Ability to integrate with our existing Identity Provider (Microsoft Entra ID) for SSO (Single Sign-On) and user provisioning (SCIM).

2.11 A centralised administrative console for policy management.

2.12 Ability to define and enforce enterprise-wide password policies.

2.13 User and group management, synced with Microsoft Entra ID.

2.14 Account recovery options for users who forget their master password, without compromising security.

2.15 Security reporting and alerts.

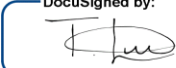
3. OTHERS - IMPORTANT
